#### Why we use CCTV

We use CCTV to help keep everyone safe. The system protects children, volunteers, parents, visitors, and the property, and helps us meet safeguarding and insurance requirements.

CCTV may be used to:

- Prevent or investigate vandalism, theft, trespass, or anti-social behaviour
- Support safeguarding and child protection
- Assist with accident or incident review
- Secure the premises when unoccupied or during low activity

CCTV is in operation in certain inside and outside areas of the Hall.

There are no cameras in toilets, changing rooms, or private spaces. Audio recording is disabled.

#### What we collect

- Visual footage only
- No sound recording
- No biometric or facial recognition technology

#### Lawful basis

We rely on **Legitimate Interests – Article 6(1)(f) UK GDPR** to operate CCTV for:

- Safety and safeguarding
- Security of the building and grounds



- Investigating incidents
- Insurance and legal compliance

## How long we keep footage

- Footage is retained for up to 30 days
- It may be kept longer if needed for a police inquiry, legal matter, insurance claim or safeguarding case
- Once no longer required, footage is securely deleted or automatically overwritten

## Who can access the footage



Access is restricted to authorised members of the Hall Committee only.

Footage may be shared with:

- Police or emergency services
- Legal representatives
- Insurance providers

It will **never** be used for general behaviour monitoring, employee surveillance, or shared publicly/social media.

## **Your rights**

You have the right to:

- Request access to CCTV footage in which you appear
- Request that we restrict or stop processing (where legally appropriate)
- Raise concerns or complaints with the Information Commissioner's Office (ICO)

Where footage contains other people, we may blur or mask those individuals before disclosure.

## Security of the system

Our CCTV is installed and maintained by:

Footage is stored securely using the **Hik-Connect** platform, which provides:

Encrypted data transmission and secure access



- Strong passwords and multi-factor authentication
- Regular system and firmware updates
- Access logging and administrator controls

Audio is permanently disabled.

CCTV does not monitor private areas, toilets, or changing areas.

## Signage and transparency

Clear CCTV signage is displayed:

- At main entrances
- Inside the Hall
- In outdoor monitored areas
