Turning barbershops into safe spaces for mental health

Delivered in partnership with Swindon and Gloucestershire Mind and PAPYRUS Prevention of Young Suicide, barbers can now sign up for free mental health training. The training will take place on Monday, 23 June, from 10am to 2pm (with lunch included), at Swindon Town Community Foundation (SN1 2EE).

The purpose is to help barbers recognise the signs of mental distress, use supportive language and signpost customers to further help if needed.

What face-to-face support is available from the Council?

Most resident enquiries can now be dealt with easily <u>online</u>, by <u>telephone</u> or by visiting our Customer Service area at Central Library in Regent Circus where staff can help with the following:

- Using the self-service touchscreens to:
  - pay rent
  - bid for council housing
  - request a housing repair
  - apply for a resident parking permit
- Applying for, or renewing, a Blue Badge or Concessionary Travel pass
- Booking a one-to-one appointment for help to complete a form
- Calling the Council Tax team using a dedicated phone line for help with your query
- · Signposting to other support services where you have specific enquiries
- Collecting parking permits and waste barrier passes

More council staff are now based at Central Library and they are available to help Monday to Friday from 10am until 5pm.

For support with homelessness or a housing emergency, residents can meet in person with our Homeless Prevention Services team based at Wat Tyler West. The team can be found via a dedicated entrance off Beckhampton Street (9am-4pm on Tuesday, Thursday, Friday and 12.30pm-4pm on Wednesday). Meanwhile, residents will need to visit the Civic Offices for:

- appointments with Swindon Register Office
- posting documents using the letterbox outside the building

You can share your views on a proposed renewal of a Public Spaces Protection Order (PSPO) which, if approved, would enable council officers and other partner agencies to continue to issue Fixed Penalty Notices to people who let their dogs foul and then fail to clear up after their pets. This will also include those that allow their dogs into enclosed children's play areas.
