## **SPOTLIGHT ON Suffolk Accident Rescue Service (SARS)**

SARS - Suffolk's Emergency Medical Charity is one of the county's most vital yet often unsung emergency response charities. Operating alongside other emergency services such as East of England Ambulance Service and Suffolk Fire & Rescue, SARS provides specialist medical care at the scene of serious incidents - often before an ambulance arrives.

SARS deploys highly skilled volunteer clinicians including anaesthetists, emergency medicine consultants, and critical care paramedics. These professionals respond to life-threatening emergencies across Suffolk and the surrounding areas, delivering advanced interventions that can make the difference between life and death. Between April 2024 and March 2025, SARS volunteers were mobilised 620 times. In over 25% of those cases, they were the first on scene. From cardiac arrests and traumatic injuries to complex medical emergencies, their expertise is a lifeline for patients in critical need.

Based in Woolpit, the charity is deeply rooted in the local community. In addition to emergency response, SARS also runs public education initiatives such as CPR awareness sessions - empowering residents with the knowledge to act confidently in a crisis.

Despite their impact, SARS receives no central government funding. Every piece of equipment, every training session, and every life-saving intervention is made possible through donations and fundraising. 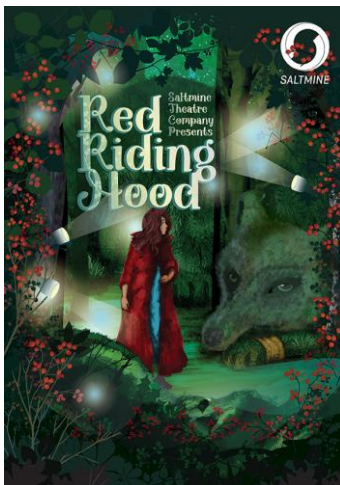

## MINUTES OF THE MEETING HELD ON 7<sup>th</sup> July 2025

1.	<b>The Chair welcomed all to the monthly meeting.</b>	
2.	Declarations of pecuniary and local non-pecuniary interests a) To receive declarations of pecuniary, local non-pecuniary interest(s) and personal interests in items on the agenda inc. gifts of hospitality exceeding £25- none b) To receive declarations of lobbying for planning matters - none c)To receive requests for dispensations - none	
3.	<b>PUBLIC FORUM</b>	
	<ul style="list-style-type: none"> <li>Members of the public—to receive questions and matters of concern from those in attendance</li> </ul> <p>Concern expressed at lorries over the weight limit with no permit still using the A1088 during the night while the A14 is closed. There are currently 103 HGVs with permits to use the road. Cllr Mellen stated there had been an ANPR van monitoring use and speed and he had asked for access to the ANPR data so misuse could be followed up, but it has been difficult to obtain this. National Highways have the data, Trading Standards monitors the weight limit and permits, and the Police fine the firms for misuse and speeding. However, getting them to work together has proved difficult. As the problem occurs at night the Police do not have the manpower to monitor all night. It was reported that houses are shaking and the road is beginning to break in places. Cllr Mellen agreed to follow up what he could. Mr. Moland clarified that speedwatch is not allowed to work at night so could not help with speeding issues. Mr. Millen felt rat runs are also occurring through other villages.</p> <ul style="list-style-type: none"> <li>Members of the public – to receive comments submitted via email</li> </ul> <p>Correspondence received concerning water leaks in Ashfield Road. In the past few weeks the road has been closed several times due to the number of leaks which have occurred as a result of the serious deterioration of the old pipe system. Request was made for the Council to raise this issue with Anglian Water and ask for a timetabled pipe replacement. The Clerk was asked to contact Anglian Water.</p> <p>Criminal damage to Evie's bench. Following emails from Mrs. Gleeson, she has reported the graffiti damage to the Police.</p> <p>Water to Allotments. Due to the recent hot spells, Mr. Walton has taken several water tankers to the area. The Trustees will investigate mains water for future use.</p>	Clerk
4.	<b>REPORTS FOR INFORMATION</b> –to receive written reports for information only <ul style="list-style-type: none"> <li>Report from County Councillor Andy Mellen – noted</li> </ul> <p>Mr. Aket commented on the Scrutiny Committee considering the educational attainment of children to be below the national attainment figures. He questioned the change from three tier to two tier a number of years ago.</p> <ul style="list-style-type: none"> <li>Report from District Councillors Harry Richardson and David Bradbury.</li> </ul> <p>Mr. Aket commented on money given to Rattlesden Church which he understood was not permitted. Cllr Richardson stated CIL could be allocated provided the Church provides a service to the community i.e. a general meeting place. Cllr Mellen stated the Church is used Monday to Friday as a meeting place for the Community.</p> <p>Mr. Aket enquired about spending £3m for a footpath and cycle way from Elmswell and Woolpit. Cllr Richardson said he believed it was due to the large developments at both Elmswell and Woolpit. Cllr Richardson agreed to get details. Mr. Aket felt a footpath from Norton to Thurston should be considered.</p>

	6.1 Bus stop at crossroads. Cllr Mellen stated he had requested markings.	
	6.2 UKPN – FIT update. The Clerk stated the request to FIT went to the Planning and Policy Committee on 4 <sup>th</sup> July and their decision was awaited.	
	6.3 Street lighting – lighting times. The Clerk outlined the costs of the upgraded and non upgraded lights. She will put together a spreadsheet of the lights and give suggestions as to which areas could be upgraded. The Clerk agreed to make enquiry as to whether funding is available from Greener Suffolk.	
	6.4 Withdrawal of Bus service. Reply from Dan's coaches stated the service had been withdrawn due to low usage, plus there is a new service from Thurston to Bury. Mr. Winstanley commented about asking Dans coaches how much it would be to retain the service, or ask how many use the service. Mr. Aket wondered if the £8m for bus service allocated to SCC could be tapped into. Mr. Winstanley agreed to follow up.

The Council had no objection to this application but made the following observations: <ul style="list-style-type: none"> <li>• The proposed dwelling appeared large for the plot</li> <li>• Being sideways on to the road did not present an aesthetic look and there is preference for front facing to fit the street scene.</li> <li>• Access and egress from the site needs to be clarified as there appeared to be limited turning and parking within the site.</li> </ul>	
	<b>7.2 FULL PLANNING APPLICATION - DC/25/02951</b> The Dog Inn, Ixworth Road, Norton Installation of pergola <b>The Council recommended approval</b>	
	<b>7.3 APPLICATION FOR OUTLINE PLANNING PERMISSION - DC/25/02900</b> Land West Of, Ixworth Road, Norton - Erection of 2 self-build dwellings (Access points to be considered, all other matters reserved) Town and Country Planning Act 1990 (as amended) The Council objected to this application. <ol style="list-style-type: none"> <li>1. More development along this stretch of open countryside gave precedence for further applications.</li> <li>2. Village facilities as mentioned in the previous refusal by the Inspectorate were not a short distance but some distance away from these properties and would necessitate use of cars especially as the houses are listed as family homes. There was no footway near the development or provision to provide one. To allow ease of access to village facilities would require residents to walk along the roadside of the A1088.</li> <li>3. There are no current bus routes running through the village to allow ease of access to facilities or larger shopping towns</li> <li>4. The site is in the countryside and therefore in an unsustainable location</li> <li>5. The scheme did not provide affordable housing (on the basis that the site should be aggregated with previous permissions)</li> <li>6. It would mean additional vehicles accessing and egressing the site near the brow of a hill.</li> </ol>

## ELMSWELL GARDEN CLUB

There was no meeting in August as the holiday season is in full swing, and club members have been enjoying time with family and friends, taking holidays, and of course, tending to our gardens.

This growing season has continued to be a tough one, with a hot, dry start, four heatwaves, and only one decent spell of wet weather in between. My own garden has been dry since April, and it has been interesting to see which plants have responded well to the conditions. Generally, those planted early in the season (March/April) have fared better than the annuals and perennials planted later in May and June. Vegetables have followed the same pattern, and trying to prevent bolting of salads has proved impossible. Recent news articles have reported farmers experiencing smaller crop yields this year, particularly cereals and brassicas. This makes me feel slightly better, as my broccoli has grown very small and scrappy this year—clearly not my crowning glori-floret.

On a more serious note, evidence shows that our winters are getting wetter while our summers grow hotter and drier. The RHS is currently researching which plants can adapt and thrive in these fluctuating conditions. While drought-tolerant plants may cope with dry spells, they may not withstand wetter winters, so plantings need to be resilient to both. If you're thinking of replacing plants in your garden next year or looking to make your garden more climate-resilient, there are lots of helpful tips on the RHS website.



At the beginning of July, club members visited Porters Lodge Garden and Tea Rooms in Cavenham. The garden, created by Craig Wyncoll and Lionel Sturgess when they moved to Porters Lodge 37 years ago, covers 3 acres plus an 18-acre woodland. It is divided into several rooms, each with different planting conditions and styles. It's a relaxing place with plenty of ideas to take home, and once you've had your fill, there is sampling to be had in the café.

Our October speaker is Chris Wiley, who will share his passion for snowdrops. Chris is a local plantsman who founded the Sustainable Plant Store in 2022 and also coordinates Bury in Bloom

Whether you are an experienced home gardener or just starting out there is always something new to learn or ideas to take home to your own garden. Non-members are always welcome and you may make some new friends.

## ELMSWELL HISTORY GROUP

Our new season got off to a wonderful start last month with Zoe Adlam's talk, "*Fool's Gold*", which discussed whether the legislation pertaining to treasure needs to be changed to improve the protection of what are known as Portable Antiquities. Zoe undertook research relating to this topic for her undergraduate dissertation, and is currently training to become a barrister. She delivered a fascinating and very informative presentation that was understood by all the audience, irrespective of their level of knowledge of legal language and the intricacies of legislation. Zoe gave us an insight into the current legislation pertaining to treasure and its antecedents in Common Law. She highlighted that there are many gaps in the present laws which do not allow for many antiquities and objects of local, national and public interest to be regarded as treasure. These finds inevitably end up with private collectors, meaning that unfortunately many of them are never exhibited in public.

She went on to explain what is regarded as treasure from the perspective of precious metals (gold and silver) and that many significant bronze antiquities, such as the Sutton Hoo Helmet, have been and are not currently regarded as treasure, because they do not have the required precious gold or silver metal content! Zoe also highlighted objects found in Suffolk, such as rings and seals that have the relevant gold content to be classified as treasure. She went on to surprise the audience with facts such as the Coroner's System by law is engaged with the process of dealing with treasure, and that 90% of all antiquities finds are made by metal detectorists.
